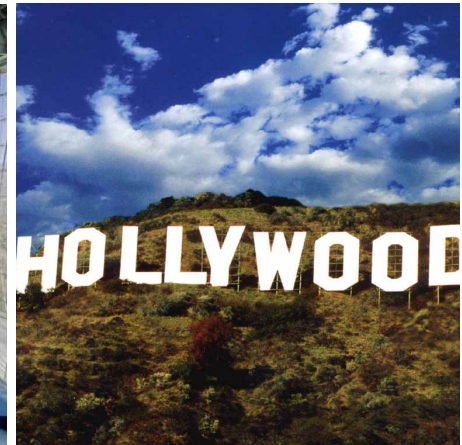

**Day 1: Arrive Los Angeles**

Today board your flight bound for **Los Angeles** to begin your **California Winter Getaway Tour**. Upon arrival meet your **Tour Director** to begin your three night stay in Los Angeles. Enjoy a **Welcome Dinner** this evening with your fellow travelers.

*Meal - (D) Overnight: Los Angeles Area*

**Day 2: Los Angeles Area Sightseeing - Beverly Hills**

Today enjoy a panoramic **Los Angeles City Tour** featuring **Downtown Los Angeles**, the **Staples Center**, **Walt Disney Concert Hall**, **Dolby Theatre**, home of the glamorous Academy Awards, **Grauman's Chinese Theatre** and the **Hollywood Walk of Fame**. Stop at the Grove & LA Farmer's Market to enjoy a bit of leisure time for shopping, wandering and a bite to eat. Later drive along the fabled **Sunset Strip** to the palm-lined streets of **Beverly Hills** and **Rodeo Drive!** Enjoy dinner at the renowned **Lawry's Restaurant** in Beverly Hills which opened in 1938 and is famous for prime rib & Lawry's Seasoned Salt.

*Meals - (B,D) Overnight: Los Angeles Area*

**Day 3: Los Angeles Area Sightseeing - Santa Monica**

This morning visit the renovated **Ronald Reagan Presidential Library**. The state-of-the-art museum takes you from Reagan's early years to his time spent as a world leader. The library also features the Air Force One used by President Reagan. Later visit the beautiful **J. Paul Getty Center Museum** which is privately funded by the John Paul Getty Trust. The Getty Center houses European paintings, drawings, sculptures, illuminated manuscripts, decorative arts and European and American photographs from a spectacular hilltop location overlooking Los Angeles. Late afternoon visit **Santa Monica** to see the famous Santa Monica Pier and Boardwalk. Return to your hotel and enjoy the remainder of the evening at leisure.

**Day 4: Port of Los Angeles - Long Beach - San Diego**

This morning travel to the Port of Los Angeles in San Pedro to visit the **USS Iowa**, now a maritime museum. The USS Iowa (BB-61), was the lead ship of the Iowa class battleship and originally commissioned for World War II in 1943. *The Big Stick* housed 2,800 sailors and hosted 3 US Presidents - Franklin D. Roosevelt, Ronald Reagan, and George H.W. Bush and numerous dignitaries during almost 70 years of service. Then a short ride brings you to Long Beach to enjoy

a **Queen Mary Walking Tour** to learn about her glamorous history, art deco beauty and her historical significance as the "Grey Ghost" during World War II. Then travel south enroute to San Diego passing through Orange County, along parts of the Pacific Ocean and then the Camp Pendleton Marine Base. Arrive in **San Diego**, 'America's Finest City' and check into your hotel for a two night stay. Famous for its miles and miles of white-sand beaches and amazing weather, the city offers an abundance of attractions and sights. Enjoy this evening at leisure.

**Day 5: San Diego Sightseeing**

This morning enjoy a **San Diego City Tour** including the historic **Gaslamp District**, the bustling **Embarcadero & Seaport Village**, **Balboa Park** and historic **Old Town - San Diego**. This afternoon enjoy a **San Diego Harbor Cruise** to see San Diego Bay from Harbor and Shelter Islands, Point Loma, and Cabrillo National Monument to North Island Naval Air Station, the Submarine Base & the Coronado Bridge. Later drive over the iconic **Coronado Bridge** to visit **Coronado Island** and its quaint downtown. See the famous Hotel del Coronado, the National Historic Landmark with its iconic red-shingled roof sits on the Pacific Ocean. This evening enjoy a **Farewell Dinner** at a local restaurant.

**Part A - Cancellation Waiver provided by PWD**

**I. Trip Cancellation Waiver (TCW)** - Guarantees full refund on all payments, except the TPP Fee itself in case of cancellation up to the time and date of departure due to the passenger's personal illness or death of a member of the immediate family; or, if the passenger must return early due to the passenger's personal illness or death of a member of the immediate family, a refund for the unused land services. Medical/official documentation required.

**II. Premier "Any Reason" Cancellation Waiver (ARCW)** - Reimburses 75% of the cancellation fees in the form of a future travel credit certificate (FTCC) valid for 1 year, if you cancel more than 48 hours prior to scheduled departure for any reason not eligible for cash refund under the TCW (Part A - I.). FTCC is non-transferable, may not be redeemed for cash and does not include any credit for the TPP Fee. The TPP Fee (if

chosen) is refundable until 180 days prior to departure & cannot be added after Final Payment. The TPP does not cover any single supplement charges due to an individual's traveling companion cancelling prior to departure. The TPP is non-transferable and valid for each applicant only. The TPP does not cover any services such as airline tickets not purchased through PWD. Cancellations, Claims & Inquiries under Part A will be administered by PWD.
